#### **Lincoln Park District**

The Lincoln Park District was formed in 1961. Located in central Illinois, the district serves approximately 30,000 residents in the City of Lincoln and surrounding areas. The Park District currently employs seven full-time, 22 part time, and 15 to 25 seasonal part-time employees. The district offers its residents 91 acres of green space at 4 locations.
